Sir,

The General Body of the Council at its meeting held on 21st & 22nd June, 2001 considered the matter with regard to approval of Padmashree Dr. D.Y. Patil Medical College for Women, Pimpri for the award of MBBS degree granted by Pune University.

The Council approved the following recommendations of the Executive Committee which I am directed to convey herewith for your information & necessary action:-

"The Executive Committee considered the compliance verification inspection report (2nd & 3rd April, 2001) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the inspection report (Dec., 2000) and decided to recommend that Padmashree Dr. D.Y. Patil Medical College for Women, Pimpri be approved for the award of MBBS degree granted by Pune University with an annual intake of 100 (hundred) students."

MBBS degree granted by Pune University is already recognised and included in the first schedule to the IMC Act, 1956, hence separate notification is not required to be issued by the Central Govt. Copy of the compliance verification inspection report (April, 2001) is enclosed. Copy of the previous inspection report (Dec., 2000) is already with the Ministry. The concerned authorities of college/University are also being informed.
