In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of MD(Pathology) qualification for 10 to 12 seats in respect of students being trained at Dr. D. Y. Patil Medical College, Hospital & Research Centre, Pimpri, Pune under Dr. D. Y.
