In this regard, it is informed that the aforesaid Compliance Report was considered by the Post Graduate Medical Education Board (PGMEB). Based on the reply furnished by the college/institute, approval of the PGMEB is hereby accorded in terms of Section 25(i) and 35(4) of NMC Act, 2019, for grant of **Recognition against increased intake of MS(General Surgery) qualification for 16 to 24 seats in respect of students being trained at Dr. D. Y. Patil Medical College, Hospital & Research Centre, Pimpri, Pune under Dr. D. Y. Patil Vidyapeeth (Deemed to be University), Pimpri, Pune**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
